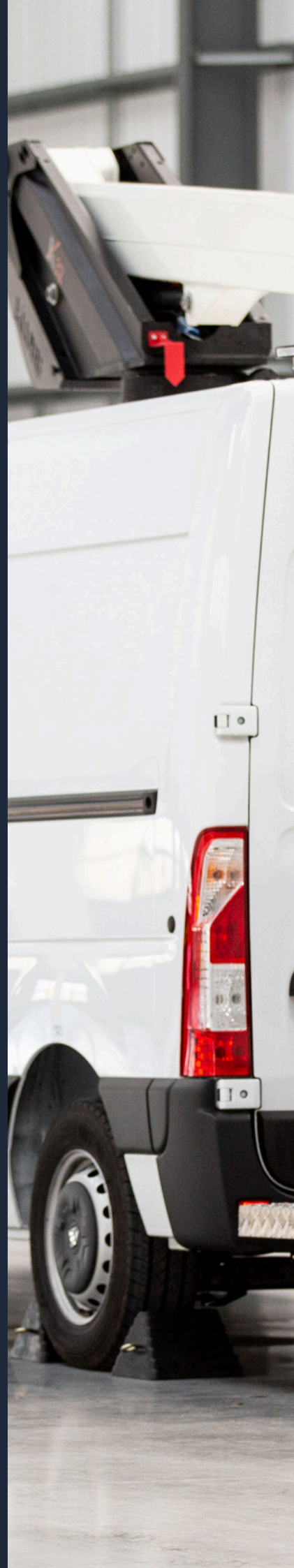

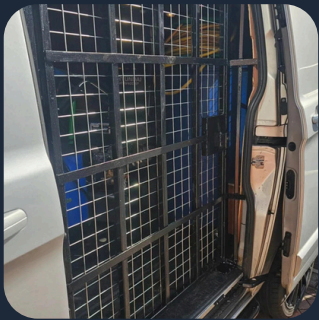

# Vehicle finance options

## Business Contract Hire

With Business Contract Hire, you commit to a fixed period between two and five years with a set mileage limit. After the contract ends, you simply return the vehicle with no further financial commitments, eliminating worries about depreciation or resale. Business Contract Hire deals include road tax for the entire term, and an optional maintenance package, covering tyre replacements, repairs, MOTs, and servicing.

## Finance Lease

Finance Lease is similar to a Business Contract Hire, in that you use the vehicle for an agreed period and up to the agreed mileage limit. However, at the end of the agreement, instead of returning the vehicle, you have to sell it to a third party and use the proceeds to pay the final rental (commonly known as a balloon payment), unless the agreement is fully amortised. Finance Lease includes road tax for the first year, and an optional vehicle maintenance package is available.

## Hire Purchase/Lease Purchase

Hire Purchase and Lease Purchase are vehicle finance agreements that allow ownership once all payments are completed, offering cash-flow-friendly options for purchasing a vehicle. These agreements involve an initial payment, regular monthly instalments, and, in the case of Lease Purchase, a final payment (commonly known as a balloon payment). Neither arrangement comes with mileage restrictions, and road tax is included for the first year of the agreement.

## Outright Purchase

Outright purchasing a vehicle entails buying it with full payment upfront, giving you immediate ownership without the need for financing or instalment payments. Though it requires a significant initial investment, outright purchase offers the advantages of complete ownership, including the flexibility in managing the vehicle and the ability to sell it or trade-in at any time.
